Results of the Annual General Meeting held on 19 November 2019

Global logistics solutions provider, WiseTech Global, reports that at the Annual General Meeting held in Sydney today, the items of business contained in the Notice of Meeting (dated 15 October 2019) were all passed by the requisite majority of shareholders.
